Mail bank check or money order to 198 West Main St, Somerville NJ 08876.** The application due date is April 22, 2019. Any application received after April 22, 2019 will require a late fee of \$100. All late application fees must be paid with cash, bank check or money order. ***All fees are non-refundable***
