Must be **10 years drug free** from the date of show. **Pro card winners must also submit to a urinalysis after they come off stage as required by WNBF rules.**

Entry fee for all classes \$60.00. Crossover Fee \$50.00 All entry fees are payable to **Bodhi by Anthony Monetti. Mail bank check or money order to 198 West Main St, Somerville NJ 08876.** The application due date is April 20, 2020. Any application received after April 20, 2020 will require a late fee of \$100. All late application fees must be paid with cash, bank check or money order. ***All fees are non-refundable***
